



**CREW CALGARY AFFILIATE MEMBERSHIP APPLICATION**

Affiliate Membership is available to companies that provide support to, or are affiliated with, commercial real estate or in the sole discretion of CREW Calgary's Board, companies that contribute to, or advance the objectives of CREW Calgary (an "Affiliate Company").

**AFFILIATE MEMBER APPLICATION PROCEDURES:**

1. The Affiliate Company must submit a completed CREW Calgary Affiliate Membership application form together with one (1) sponsorship reference letter from a current CREW Calgary Member or a business associate active in the commercial real estate industry.
2. Applications for Affiliate Membership are subject to review and approval by the Membership Committee and/or the CREW Calgary Board, which may approve/disapprove an applicant in its sole discretion, taking into account, among other requirements, the need to balance the membership as to (i) the type of commercial real estate industry represented, and (ii) the then current number of Affiliate Company members, which shall not exceed ten percent (10%) of the CREW Calgary membership as a whole.
3. Upon Affiliate Membership approval, the Affiliate Company shall: (a) make payment of the Annual Membership Fee; and (b) appoint its representative who must be a current employee of the Affiliate Company ("Affiliate Representative") who may attend all events at member rates established from time to time. With the exception of Members Only events, additional guests of the Affiliate Company may attend register and attend CREW Calgary events at non-member rates.

**ONGOING AFFILIATE MEMBERSHIP REQUIREMENTS:**

- Annual Affiliate Membership Fee for 2012 is \$1,500 for the calendar year (\$1,250 after July 1) plus GST (GST # 814266474RT0001). Affiliate Memberships expire annually on December 31.
- Approved Affiliate Membership applicants will be invoiced by CREW Network and provided directions to register their account and make payment of the Annual Membership Fee.
- Affiliate Member Company must provide support to, or be affiliated with commercial real estate.
- Affiliate Member Company must maintain an established reputation in the business community and commercial real estate industry.
- Affiliate Company's account must be in good standing.
- Affiliate Representative cannot serve as an Officer or Director of CREW Calgary.
- Affiliate Company must notify CREW Calgary if it appoints a replacement Affiliate Representative.
- In the event an Affiliate company becomes insolvent or dissolves, the Affiliate Company shall notify CREW Calgary within thirty (30) days and the Affiliate Membership will be terminated without compensation to the Affiliate Company.
